

THE EQUALIZER 2 SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

"THE EQUALIZER 2 SWEEPSTAKES" (the "Sweepstakes") starts at 12:00 a.m. Pacific Time ("PT") on November 13, 2018 and ends at 11:59 p.m. PT on December 10, 2018 ("Sweepstakes Period"). During the Sweepstakes Period, entry will take place online at www.theequalizer2sweeps.com the ("Website"). The sponsor of the Sweepstakes is Sony Pictures Home Entertainment Inc., 10202 West Washington Blvd., Culver City, CA 90232 (the "Sponsor"). The Sweepstakes shall be subject to these Official Rules, and by entering, all participants agree to be bound by the terms and conditions herein.

The personally identifiable information you provide in connection with the Sweepstakes Entry will be collected, stored and used in accordance with Sponsor's [Privacy Policy](#).

ELIGIBILITY: THE SWEEPSTAKES IS OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES AND THE DISTRICT OF COLUMBIA (THE "ELIGIBILITY AREA"), EIGHTEEN (18) YEARS OF AGE OR OLDER AS OF THE DATE OF THEIR ENTRY. Employees of Sponsor, and any of Sponsor's parents, subsidiaries, affiliates, advertising and promotion agencies, and other Sponsor-authorized designees associated with the design, administration, prize providing and/or fulfillment of the Sweepstakes (collectively, the "Sweepstakes Entities"), as well as members of such employees' immediate families (spouses, children, siblings, parents, grandparents and their respective spouses, regardless of where they reside) and/or households (whether or not related), are not eligible to participate in the Sweepstakes or win. HOW TO ENTER THE SWEEPSTAKES: There are four (4) entry periods (each, an "Entry Period") during the Sweepstakes Period, as set forth below. Each Entry Period is a separate chance to win. Each Entry Period will begin and end as follows:

Entry Period #1: Begins at 12:00 a.m. PT on November 13, 2018 and ends at 11:59 p.m. PT on November 19, 2018;

Entry Period #2: Begins at 12:00 a.m. PT on November 20, 2018 and ends at 11:59 p.m. PT on November 26, 2018;

Entry Period #3: Begins at 12:00 a.m. PT on November 27, 2018 and ends at 11:59 p.m. PT on December 3, 2018;

Entry Period #4: Begins at 12:00 a.m. PT on December 4, 2018 and ends at 11:59 p.m. PT on December 10, 2018.

During each Entry Period, visit the Website and, when prompted, complete the online Sweepstakes entry form by: (1) watching the clip, (2) providing all required information including your name, telephone number, date of birth, zip code, gender and email address, (3) agreeing to the Official Rules and Sponsor's Privacy Policy, and (4) clicking on the "SUBMIT" button to be electronically entered (such process referred to as the "Sweepstakes Entry"). The process of entering the Sweepstakes by submitting an online Sweepstakes Entry may be referred to individually herein as "Entry" and collectively as "Entries". Individuals submitting Entries are "Entrants." **LIMIT ONE ENTRY PER ENTRANT PER ENTRY PERIOD.** All Entries for a particular Entry Period must be received by the end of that Entry Period to be eligible. Entries that are not selected as a winner in a Random Drawing (as defined below) will not remain eligible for any/all subsequent Random Drawings. The Website's clock will be the official timekeeper for this Sweepstakes.

PRIZES: Four (4) prizes (each, a "Prize") will be awarded in the Sweepstakes. Each Prize will consist of The Equalizer on Blu-ray Disc autographed by Denzel Washington and Antoine Fuqua, The Equalizer 2 on Blu-ray Disc, and a Suunto Core watch. The approximate retail value ("ARV") of each Prize is Two Hundred Seventy-Five Dollars (\$275.00).

The winner of a Prize may be referred to herein as the "Prize Winner." Each Prize is non-transferable, non-assignable, non-substitutable and may not be redeemed for cash. Sponsor reserves the right to substitute a Prize with one of comparable or greater value at any time in its sole discretion. Each Prize may not be sold, bartered or exchanged by Prize Winner. All federal, state and local taxes and any other costs and expenses associated with Prize acceptance and use not specified herein as being provided, are the sole responsibility of Prize Winner. All Prize details are at Sponsor's sole discretion. Each Prize is awarded "as is" with no warranty or guarantee, either express or implied by Sponsor.

WINNER SELECTION: At the conclusion of each of the four (4) Entry Periods, one (1) potential Prize Winner will be selected by Sponsor in a random drawing from among all eligible Sweepstakes Entries received during such Entry Period for a total of four (4) random drawings in the Sweepstakes (each, a "Random Drawing"). Sponsor's decision regarding the result of each Random Drawing shall be final and binding. Potential Prize Winner's failure to return all required forms in this five (5) day time period may result in the potential Prize Winner being disqualified and an alternate Prize Winner being selected at Sponsor's sole discretion. Each Prize will be delivered within ninety (90) days of the completion of the Prize Winner determination/verification process via mail or other delivery service selected at the sole discretion of the Sponsor. By entering the Sweepstakes, each Entrant agrees: (i) to be bound by these Official Rules and by all applicable laws and decisions of Sponsor which shall be binding and final; (ii) to waive any rights to claim ambiguity with respect to these Official Rules; (iii) to waive all of his/her rights to bring any claim, action, or proceeding against any of the Sweepstakes Entities in connection with the Sweepstakes; and (iv) to release, indemnify, and hold harmless each of the Sweepstakes Entities and each of their respective officers, directors, employees, agents, shareholders, representatives, successors and assigns (collectively the "**Releasees**"), from any liability (including, but not limited to, liability for defamation, libel, slander, invasion of privacy, infringement of publicity or any intellectual property rights, any property loss, damage, personal injury, bodily injury, death, expense, accident, delay, inconvenience or irregularity, and any indirect, incidental, consequential, special, punitive or exemplary damages of any kind even if the Releasees have been advised of the possibility of such loss or damages), costs and expenses (including, without limitation, reasonable outside attorneys' fees) that may arise in connection with: (a) the use, by any Entrant, of the Website, and any claims made by any such Entrant's friends that their publicity, privacy and/or other proprietary rights were violated by such Entrant's use of the Website, (b) the Sweepstakes, including but not limited to any Sweepstakes-related activity or element thereof, and the Entrant's Entry, participation or inability to participate in the Sweepstakes, (c) typographical errors in these Official Rules or any Sweepstakes promotional materials, (d) acceptance, possession, defects in, use, misuse or inability to use a Prize (or any component thereof) (including any activity related thereto), (e) any change in the prizing (or any components thereof) due to unavailability, business or other considerations, or for any other reasons beyond Sweepstakes Entities' control, including but not limited to by reason of any acts of God, any action(s), regulation(s), order(s) or request(s) by any governmental or quasi-governmental entity (whether or not such action(s), regulation(s), order(s) or request(s) prove(s) to be invalid), equipment failure, threatened or actual terrorist acts, earthquake, war, fire, flood, explosion, unusually severe weather, hurricane, embargo, labor dispute or strike (whether legal or illegal), labor or material shortage, transportation interruption of any kind, work slow-down, civil disturbance, insurrection, riot, or any other cause, or as otherwise permitted in these Official Rules, (f) any interruptions in or postponement, cancellation, or modification of the Sweepstakes, (g) mechanical, electronic, computer, network, human or other errors, including, without limitation, any errors or problems that may occur in connection with the administration of the Sweepstakes, the allowing of access to the Website, and the determination and announcement of the Prize Winner, (h) incorrect or inaccurate transcription, receipt or transmission of Entries (including, without limitation, the Entry information or any parts thereof), (i) any technical malfunctions or unavailability of the Website or any telephone network, computer online system, computer timing and/or dating mechanism, computer equipment, software, or Internet service provider, or mail or delivery service utilized by any of the Releasees or by an Entrant, (j) interruption or inability to access the Sweepstakes, the Website or any online service via the Internet due to hardware or software compatibility or other problems, (k) any damage to Entrant's (or any third person's) computer and/or its contents related to or resulting from any part of the Sweepstakes, (l) any lost/delayed data transmissions, omissions, interruptions, defects, and/or any other errors or malfunctions, (m) any late, lost, misdirected, delayed, garbled, corrupted, destroyed or incomplete Entries, (n) any wrongful, negligent, or unauthorized act or omission on the part of any of the Releasees and/or (o) lost, late, stolen, misdirected, damaged or destroyed prizing (or any element thereof).

Illegible, incomplete, mechanically reproduced Entries, and Entries in excess of the number stated above (if any), will be disqualified. Entries will not be acknowledged or returned. False, fraudulent or deceptive Entries or acts shall render Entrants ineligible.

If for any reason the Sweepstakes is not capable of running as planned, or if the Sweepstakes or the Website (or any portion(s) thereof) becomes corrupted or does not allow the proper conduct of the Sweepstakes or processing of Entries in accordance with these Official Rules, or if infection by computer virus, bugs, tampering, unauthorized intervention, actions by Entrants, fraud, technical failures, or any other causes, in the Sponsor's sole opinion, corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Sweepstakes or the granting of any Prize, Sponsor reserves the right, in its sole discretion, to disqualify any individual implicated in such action and/or to cancel, terminate, modify, or suspend the Sweepstakes or any portion thereof. In the event the Sweepstakes is cancelled or terminated, and to the extent possible as determined by Sponsor, Sponsor will conduct random drawings (as detailed above) to select the Prize Winners from among all eligible, non-suspect Entries received prior to the time of the action or event warranting such cancellation and/or termination, and to award the Prize(s) (or any awardable portion(s) thereof) using the Prize Winner determination procedure outlined above. In the event that Sponsor determines that there are no eligible Entrants, Sponsor reserves the right in its sole discretion to not award any Prize (or any portion thereof). ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DELIBERATELY DAMAGE THE WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND/OR CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES (INCLUDING ATTORNEYS' FEES) FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW. If a dispute arises about the identity of an Entrant, the Entry will be deemed submitted by the authorized account holder of the email account provided in the Sweepstakes Entry and he/she must comply with these Official Rules. The "authorized account holder" is defined as the natural person who is assigned an email address by an Internet access provider, on-line service provider or other organization responsible for assigning email addresses. A potential Prize Winner may be requested to provide the Sponsor with proof that the potential Prize Winner is the authorized user of the email account associated with the winning Entry and that all eligibility and other requirements are met.

THE ARBITRATOR SHALL BE SELECTED BY MUTUAL AGREEMENT OF THE PARTIES OR, IF THE PARTIES CANNOT AGREE, THEN BY SELECTING AN ARBITRATOR FROM A LIST OF ARBITRATORS SUPPLIED BY JAMS (JUDICIAL ARBITRATION AND MEDIATION SERVICES). IF THE PARTIES STILL CANNOT AGREE ON AN ARBITRATOR, THE ARBITRATOR SHALL BE APPOINTED BY JAMS. THE ARBITRATION SHALL BE A CONFIDENTIAL PROCEEDING, CLOSED TO THE GENERAL PUBLIC. THE ARBITRATOR SHALL ISSUE A WRITTEN OPINION STATING THE ESSENTIAL FINDINGS AND CONCLUSIONS UPON WHICH THE ARBITRATOR'S AWARD IS BASED. THE PARTIES WILL SHARE EQUALLY IN PAYMENT OF THE ARBITRATOR'S FEES AND ARBITRATION EXPENSES AND ANY OTHER COSTS UNIQUE TO THE ARBITRATION HEARING (RECOGNIZING THAT EACH SIDE BEARS ITS OWN DEPOSITION, WITNESS, EXPERT AND ATTORNEYS' FEES AND OTHER EXPENSES TO THE SAME EXTENT AS IF THE MATTER WERE BEING HEARD IN COURT). NOTWITHSTANDING THE FOREGOING, THE ARBITRATOR MAY REQUIRE THAT SUCH FEES BE BORNE IN SUCH OTHER MANNER AS THE ARBITRATOR DETERMINES IS REQUIRED IN ORDER FOR THIS ARBITRATION CLAUSE TO BE ENFORCEABLE UNDER APPLICABLE LAW.

GOVERNING LAW: Each Entrant acknowledges that the internal substantive laws (as distinguished from the choice of law rules) of the State of California and the United States of America applicable to contracts made and performed entirely in California shall govern the validity and interpretation of these Official Rules and all other causes of action (whether sounding in contract or in tort) arising out of or relating to these Official Rules or the Sweepstakes.
