

**“HOTEL TRANSYLVANIA 3 Sweepstakes / Win A Bahamas Cruise For You And Your Family”
Official Rules (“Rules”)**

OVERVIEW: The “HOTEL TRANSYLVANIA 3 Sweepstakes / Win A Bahamas Cruise For You And Your Family” (“**Sweepstakes**”) promotes the motion picture “Hotel Transylvania 3” (the “**Picture**”). The Sweepstakes is sponsored by Columbia Tristar Marketing Group, Inc., 10202 W. Washington Blvd., Culver City, CA 90232 (the “**Sponsor**”). This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Snap, Inc. You understand that at the time of entry in the Sweepstakes you will be providing your information to Sponsor and not to Snap, Inc. Any questions, comments or complaints regarding this Sweepstakes should be addressed to Sponsor and not to Snap, Inc.

WHO: Open only to legal residents of the forty-eight (48) contiguous Continental United States & the District of Columbia, 13 years old or older (“Entrant(s)”). An individual under the age of majority in his/her jurisdiction of legal residency (a “Minor”) should have his or her parent’s or legal guardian’s permission before participating in the Sweepstakes.
