**SWEEPSTAKES ENTRY PERIOD & SPONSOR:** The "Spider-Man: No Way Home" Premiere Sweepstakes ("Sweepstakes") promoting the motion picture release of "Venom: Let There Be Carnage" ("Picture") starts at 9:00am Pacific Time ("PT") on 10/28/21 and ends at 11:59pm PT on 11/1/21 (the "Entry Period").

The Sweepstakes is subject to these official rules (the "Official Rules") and by entering, entrant agrees to be bound by the terms and conditions herein and to all applicable federal, state and local laws.

#### (2) How to Enter via Online Entry Form:

Random drawing will be conducted by West Coast Marketing, an independent judging organization.
