KEY COVID Protocols

We're modifying some activities that will promote safety and security on the Lot and at SPE locations.



Weekly Health Screening: STUDIO ACCESS STEPS

Bring your **badge** for studio entry. Watch for emails from "Studio Access" every Sunday and read all questions.

1) Are you currently experiencing any COVID-19 symptoms or have you experienced COVID -19 symptoms within the past 10 days^{*}, including but not limited to:

Cough, Shortness of breath or difficulty breathing, Fever, Chills, Muscle pain, Fatigue, Headache, Sore throat New loss of taste or smell, Congestion or runny nose, Nausea or vomiting, Diarrhea Are you subject to an isolation or guarantine order?

- Regardless of vaccination status, have you tested positive for COVID-19 within the last ten (10) days?* 2)
- 3) Have you been in close physical contact in the last ten (10) days** with: Anyone who has COVID-19?

OR

Close physical contact is defined as being within 6 feet of an infected/symptomatic person for a cumulative total of 15 minutes or more over a 24-hour period starting from 48 hours before illness onset (or, for asymptomatic individuals, 48 hours prior to test specimen collection).

*If you have been cleared by Sony Pictures Medical or by your employer to end your isolation period answer "no" to this question.

**If you have been cleared by Sony Pictures Medical or your employer to end your quarantine period, are fully vaccinated and boosted or not yet booster eligible, or have tested positive using a viral test for COVID-19 within the past 90 days and have recovered, answer "no" to this question.


Vaccinations

SPE requires all non-union and L174 employees working on-site at U.S. offices to be fully vaccinated.

The vaccine requirement is subject to reasonable accommodations as required by law for individuals who cannot be vaccinated due to disability or based on a sincerely held religious belief, practice or observance.

Contact <u>PO EmployeeDirect@spe.sony.com</u> or your local P&O partner to make an accommodation request.

Once the Verification process is complete a decal will be placed on SPE badges.



Vaccination Verification Process

To complete your vaccine verification, follow these steps: (See October 12 email for virtual option). More info here

- 1) Sign up <u>online</u> to start the process.
- 2) Next, verify your vaccination information, in person on virtually.
 - a) In person, visit the Studio Service Center on Main Street Monday Friday, 8 a.m. 4 p.m.
 - **b)** Virtually, email vaccine_verification@spe.sony.com to set up a time to verify via Teams, which typically takes less than 5 minutes.
 - Please include three times when you are available between 7 a.m. and 7 p.m., Monday through Friday.
 - Same day appointments can be accommodated.
- 3) The following items are required to complete your verification:
 - a) the confirmation email you receive once you sign up,
 - b) your SPE Badge, and
 - c) your Vaccine Card (digital or hard copy).
- 4) Once you complete these steps, you will receive a verification sticker on your employee badge at the Studio Service Center
 - Lanyards or clips will be made available for all employees so that badges remain visible.

Flex Schedules

Employees will have flex schedules through at least June 2022 Be in office 3 days week Option to work up to 2 days remotely Set schedule with your manager Los Angeles County Department of Public Health lifted most of its indoor mask requirements for public settings, but at the same time, strongly recommends wearing masks in many indoor spaces and crowded settings. Here on the lot in Culver City, we will be following similar guidance.

Fully vaccinated employees will no longer be required to wear masks indoors. There are, however, some important exceptions:

- Unvaccinated employees who have approved accommodations to return must continue to wear masks unless they are alone in an office or other private setting.
- Employees who are covered by a collective bargaining agreement that requires wearing masks must continue to mask at work.
- There may be certain locations, events or meetings designated by the company as requiring masks (e.g., crowded settings, accommodation of high-risk participants, etc.). Please watch and follow instructions on invitations and posted signage, and consult with P&O and Safety and Security regarding when such designations may be appropriate.

Aside from these exceptions and barring any changes in COVID conditions in L.A. County, masking on the lot will now be a personal choice. If employees are more comfortable wearing masks, then they are, of course, free to continue doing so. No employees should feel obligated or pressured to remove their face mask while in the office if they don't feel comfortable. We ask that everyone stay mindful and respectful of your colleagues and their comfort levels during this period of adjustment over the coming weeks.

Security will provide a required type of mask upon entry if you need one. Or to request a mask, please contact <u>StudioServiceCenter@spe.sony.com</u>.



Physical Distancing

There are currently no specific physical distancing requirements in effect in non-production areas.

In addition, there are no capacity restrictions in place at this time.

Reminder: For production areas, the industry's Return To Work Agreement remains in effect.

HVAC UPGRADES

- 1. Most of the buildings and stages have been upgraded to Merv 13 filtration which provides enhanced filtration and filtering of bacteria, virus carriers, pet dander, smoke, smog, mites, mold spore, lint and dust.
- 2. Many of the buildings and stages have been upgraded with UV lights installed inside the unit at the coils where it is safe and can instantly kill viruses, bacteria, and mold.
- 3. Most of **our larger buildings have what's called outside air economizers** which allows us to increase or decrease the amount of outside fresh air we introduce into the building. We are increasing the amount of outside air as well as the number of air exchanges in our buildings.
- 4. In smaller buildings that may have smaller HVAC units, we have fewer people, more private offices, and in many cases operable windows which will also allow people more outside fresh air.
- 5. Our larger newer buildings have very robust HVAC systems.
- 6. Cleaning There will be increased cleaning and disinfecting for high touch areas like elevator push buttons; door handles in building entrances and restroom doors, etc. They will be wiped down daily using various industry standard disinfectants.

| TIPS AND REMINDERS

- Don't forget your **badge!**
- If you start to feel sick at work, you should go home immediately. (Stay home if you don't feel well.)
- Please do not self-relocate to another **workspace**; if you have a concern about your location, reach out to your P&O captain.

Need to Know Information For Your Reference

COVID-19 FACTS

- COVID-19 is an infectious disease that can be spread through the air when an infectious person talks or vocalizes, sneezes, coughs, or exhales
- **Particles containing the virus can travel more than six feet**, especially indoors, so physical distancing, face coverings, increased ventilation indoors, and respiratory protection, decrease the spread of COVID-19, but are most effective when used in combination.
- COVID-19 may be transmitted when a person touches a contaminated object and then touches their eyes, nose, or mouth, although that is less common
- An infectious person may have no symptoms
- Vaccination is effective at preventing COVID-19 and protecting against both transmission and serious illness or death.
- Please refer to the CDC and Los Angeles County Public Health websites for more information

KNOW THE SYMPTOMS AND WHAT TO DO

Symptoms of COVID-19 may include:

- Fever or chills
- Cough
- Shortness of breath or difficulty breathing
- Fatigue
- Muscle or body aches
- Headache
- New loss of taste or smell
- Sore throat
- Congestion or runny nose
- Nausea or vomiting
- Diarrhea

If you have symptoms:

- Do not come to the workplace (if at work, go home)
- Contact your medical provider for advice or treatment
- Contact P&O for LOA info
- Get tested

Call 911 or your local emergency facility for serious symptoms including:


- Trouble breathing
- Persistent pain or pressure in the chest
- New confusion
- Inability to wake or stay awake
- Bluish lips or face

FOLLOW ALL SAFETY MEASURES

- Wash your hands often with soap and water for at least 20 seconds. Use hand sanitizer if soap and water are not available.
- Avoid touching your eyes, nose, and mouth
- Cover your mouth and nose with a tissue when you cough or sneeze. Wash hands after.
- **Don't shake hands** or greet people in a way that breaks physical distance requirements.
- Avoid using other coworkers' phones or other work tools and equipment, when possible. If necessary, clean and disinfect them before and after use.
